ATODLEN 1 – Amrywio

1. Bydd "Gorchymyn 2007 (Pont Quarter Mile yr A4059 i Gylchfan Abercynon) Cyngor Bwrdeistref Sirol Rhondda Cynon Taf" yn cael ei amrywio trwy ddileu Atodlen 2 yn ei chyfanwydd.

ATODLEN 2 – Terfyn Cyflymder 40 mya

1. A4059 Heol Newydd, Abercynon

- a. Y rhan honno o'r A4059 Heol Newydd, o bwynt sydd 300 metr i'r dwyrain gyffordd yr A4059 â'r B4275 i bwynt sydd 300 metr i'r gogledd-orllewin o gyffordd yr A4059 â'r B4275. Am bellter o tua 600 metr.

ATODLEN 3 – Terfyn Cyflymder 50mya

1. A4059 Heol Newydd, Abercynon

- a. Y rhan honno o'r A4059 Heol Newydd o'i chyffordd â chylchfan yr A470 i gyfeiriad y gorllewin i bwynt sydd 300 metr i'r dwyrain o gyffordd yr A4059 â'r B4275. Am bellter o tua 1200 metr.

2. Ffordd Gyswilt ar draws y Cwm yr A472 - Abercynon / Treharris (Cyngor Bwrdeistref Sirol Merthyr Tudful)

- a. Y rhan honno o Ffordd Gyswilt ar draws y Cwm yr A472 (traphont) o'i chyffordd â chylchfan yr A470 i gyfeiriad y dwyrain am bellter o tua 264 metr

3. A4059 Heol Newydd -Abercynon i Aberpennar

- a. Y rhan honno o'r A4059 o bwynt sydd 300 metr i'r gogledd-orllewin o gyffordd yr A4059 â'r B4275 i gyfeiriad y gogledd-orllewin i bwynt sydd 285 metr i'r gogledd-orllewin o ganol y ffordd fynediad sy'n arwain at Barc Busnes Cwm Cynon. Am bellter o tua 2565 metr.

4. A4059 Heol Newydd / Heol y Gamlas - Aberpennar i Gwm-bach

- a. Y rhan honno o'r A4059 Heol Newydd o bwynt sydd 53 metr i'r gogledd-orllewin o'i chyffordd â Heol y Felin i gyfeiriad y gogledd-orllewin i Heol y Gamlas (A4059) am bellter o tua 1493 metr.

(VARIATION AND SPEED LIMIT) ORDER 202*

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make various Orders under Sections 1, 2, 4, 81, 82 and 84 of the Road Traffic Regulation Act 1984 ("the 1984 Act"), and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Orders as specified in Schedule 1
2. Introduce a 40mph Speed Limit on the lengths of roads specified in Schedule 2
3. Introduce a 50mph Speed Limit on the lengths of roads specified in Schedule 3

SCHEDULE 1 – Variation

1. The "Rhondda Cynon Taff County Borough Council (A4059 Quarter Mile Bridge to Abercynon Roundabout) Order 2007" shall be varied by the removal of Schedule 2

SCHEDULE 2 – 40mph Speed Limit

1. A4059 New Road, Abercynon

- a. That section of the A4059 New Road, from a point 300 metres east of the junction of the A4059 and B4275 to a point 300 metres north-west of the junction of the A4059 and B4275. A distance of approximately 600 metres

SCHEDULE 3 – 50mph Speed Limit

1. A4059 New Road Abercynon

- a. That section of the A4059 New Road, from its junction with the A470 roundabout in a westerly direction to a point 300 metres east of the junction of the A4059 and B4275. A distance of approximately 1200 metres.

2. A472 Cross Valley Link Road – Abercynon / Treherri (Merthyr Tydfil County Borough Council)

- a. That section of the A472 Cross Valley Link Road (viaduct) from its junction with the A470 roundabout in an easterly direction for a distance of approximately 264 metres


3. A4059 New Road - Abercynon to Mountain Ash

- a. That section of the A4059 from a point 300 metres north-west of the junction of the A4059 and B4275 in a north-westerly direction to a point 285 metres north-west from the centreline of the access road leading to Cwm Cynon Business Park. A distance of approximately 2565 metres.

4. A4059 New Road / Canal Road – Mountain Ash to Cwmbach

- a. That section of the A4059 New Road from a point 53 metres north-west of its junction with Mill Road in a north-westerly direction onto Canal Road (A4059) for a distance of approximately 1493 metres
