Nod y marciau Dim Stopio ar 'Ysgol Cadwch yn Glir' yw atal parcio rhwng 8am a 5pm o ddydd Llun i ddydd Gwener er mwyn sicrhau diogelwch ar y ffyrdd wrth y fynedfa newydd i'r ysgol ar amseroedd gollwng a chasglu. Mae angen newidiadau i'r cyfyngiadau gwahardd aros ar unrhyw adeg (llinellau melyn dwbl) hefyd yn rhan o waith datblygu'r ysgol newydd gyda chyfyngiadau Dim Llwytho rhwng 8am a 9:30am a 2:30pm a 4pm, o ddydd Llun i ddydd Gwener, a hynny i atal tagfeydd traffig ger yr ysgol ar Lôn y Cefn.

Caiff llinellau melyn dwbl a chyfyngiadau dim llwytho hefyd eu cynnig wrth gyffordd Lôn y Cefn â phriffordd y B4273 (Teras Glyn-coch a Heol Ynys-y-bwl). Cefn Lane, Glyncoch - Pre Statutory Consultation

Changes to No Stopping on 'School Keep Clear' Markings, Double Yellow Lines and No Loading restrictions.

The Council is proposing to change the existing No Stopping on 'School Keep Clear' Markings and make changes to the Double Yellow Lines on Cefn Lane as part of the new school development for Autumn / Winter 2026. The changes proposed, follow on from a review of waiting restrictions and feedback from an initial informal consultation on the double yellow lines and no loading restrictions at Cefn Lane.

The No Stopping on School Keep Clear markings are to prevent parking between 8:00am and 5:00pm Monday to Friday in the interests of road safety at the new school access at drop off and pick up times. Changes to the prohibition of waiting at any time restrictions (double yellow lines) are also required for the new school development with No Loading between 8:00am – 9:30am & 2:30pm – 4:00pm, Monday to Friday to prevent congestion at the school on Cefn Lane.

Double yellow lines and no loading are also proposed at the junction of Cefn Lane with the main road B4273 (Glyncoch Terrace and Ynysybwll Road). The No loading at the junction will be between 8am and 6pm Monday to Friday and a section of double yellow lines with No loading at any time opposite the junction entrance. The changes are in the interests of road safety and to maintain visibility at this junction at all times.

Details of the proposals are shown on the attached drawing **TM25/319/IC/P05** which may also be viewed at **www.rctcbc.gov.uk/traffic**.

For your convenience, a response form and a postage paid addressed envelope is enclosed. Alternatively, you may wish to respond by e-mail to trafficservices@rctcbc.gov.uk. Responses should be returned with your observations by 21 October 2025.

If there is no response by that date, it shall be assumed that you have no comment to make on the proposals.

The Council will make no formal response to your comments at this stage. However your comments will advise the design prior to the next stage of the project, which will be formal Public Notice.
