(VARIATION AND WAITING RESTRICTIONS) ORDER  
2025 AND (PEDESTRIAN CROSSING) NOTICE 2025**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council propose to make a waiting restrictions Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act"), and after consultation with the Chief Officer of Police in accordance with Section 23(2)(a) of the said Act proposes the following and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Order specified in Schedule 1
2. Introduce waiting restrictions on the roads identified in Schedule 2
3. Establish a Puffin Pedestrian Crossing at the location specified in Schedule 3

**SCHEDULE 1 - Variation**

1. The "Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2012" shall be varied by the removal of the following order in its entirety:  
"Rhondda Cynon Taff County Borough Council (Trebanog Road, Trebanog) (Prohibition of Waiting At Any Time) Order 2012"

**SCHEDULE 2 – Prohibition of Waiting At Any Time**

1. The western side of Trebanog Road A4233 from a point 9 meters south of its junction with Olive Terrace, northwards for a distance of 22.5 metres
2. The eastern side of Trebanog Road A4233 from the common boundary of No.158 and No.159 Trebanog Road, southwards to the un-named road leading to No.162 – No.173 Trebanog Road for a distance of 24.5 metres
3. The northern side of the un-named road leading to No. 162 – No. 173 Trebanog Road from its junction with Trebanog Road A4233, eastwards for a distance of 5 metres
4. The southern side of the un-named road leading to No. 162 – No. 173 Trebanog Road from its junction with Trebanog Road A4233, eastwards for a distance of 12.5 metres
5. Both sides of Olive Terrace from its junction with Trebanog Road westwards for a distance of 10 metres

**SCHEDULE 3 – Puffin Pedestrian Crossing**

1. To be established at a point 20 metres south of the junction centreline of the unnamed road leading to No. 162 – No. 173 Trebanog Road
