Yn rhan o'r adolygiad blynyddol o'r bobl anabl sy'n bodloni'r meini prawf o ran gofal cymdeithasol, mae cynigion wedi eu paratoi ar gyfer cyflwyno 12 o Fannau Parcio Unigol i Ddeiliaid Trwydded a diwygio 15 o'r Gorchmynion presennol trwy ddileu Mannau Parcio Unigol i Ddeiliaid Trwydded does dim eu hangen mwyach mewn lleoliadau amrywiol yn Rhondda Cynon Taf.

Ystyrir y bydd y mesurau yma'n darparu cyfleuster parcio dynodedig ar gyfer y person anabl ac yn helpu i wella ansawdd bywyd yr unigolyn trwy gael gwared â phryderon ynglŷn â chyfleusterau parcio gerllaw'r eiddo.

**STATEMENT OF REASONS**

As part of an annual review for disabled persons who meet the social care eligibility criteria, proposals have been developed to introduce 12 No. Individual Permit Parking Places (IPPP) and amend 15 No. existing Orders by removal of IPPP which are no longer required at various locations in Rhondda Cynon Taf.

It is considered that these measures will provide a dedicated parking facility for the disabled person and help improve quality of life for the individual by removing concerns regarding parking opportunity in the immediate vicinity of the property.

These measures are proposed under the Road Traffic Regulation Act 1984 to facilitate the passage of traffic, prevent the likelihood of danger and to improve safety.
