NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council (“the Council”) in exercise of its powers under Sections 1, 2, 4, 32,45, 46, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers, propose to make various orders the general effect of which will be: -

1. To Revoke the Traffic Regulation Orders specified Schedule 1
2. To Vary the Traffic Regulation Orders as specified in Schedule 2
3. Designate the lengths of roads specified in Schedule 3 as Individual Permit Parking Places
4. Introduce waiting restrictions as specified in Schedule 4
5. Introduce residents parking as specified in Schedule 5

 - Schedule 8 – Residents Parking Only, Monday to Saturday Inclusive, Item 4, Primrose Street – Part (a) shall be removed in its entirety from the Schedule

15 Pleasant View, Tylorstown	Between its common boundary with No. 14 and its common boundary with No. 16
19 Aubrey Road, Glynfach, Porth	Between its common boundary with No. 18 and its common boundary with No. 20
2 Pinewood Drive, Trealaw	From a point 1 metre east of its common boundary with No. 1, eastwards for a distance of 6 metres
70 Primrose Street, Tonypany	Between its common boundary with No. 69 and its common boundary with the Mid Rhondda Central Workingmen's Club
4 Danygraig Terrace, Tonypany	From a point 5 metres north-east of its common boundary with No. 3, north-eastwards for a distance of 6 metres
9 Maindy Crescent, Ton Pentre (opposite)	On the north-eastern side of Maindy Crescent, from a point opposite the common boundary of No. 8 and No. 9, north-westwards for a distance of 6 metres
12 Rheolau Terrace, Trehafod	Between its common boundary with No. 11 and its common boundary with No. 13
1 Ninian Street, Treorchy	From its common boundary with No. 2, south-westwards for a distance of 4.5 metres
37 Oakland Terrace, Cilfynydd	Between its common boundary with No. 36 and its common boundary with No. 38

SCHEDULE 4 – PROHIBITION OF WAITING AT ANY TIME


- North eastern side, from a point 10 metres south east of its junction with Derwydd Road, north westwards for a distance of 23.5 metre
- South western side, from a point 10 metres south east of its junction with Derwydd Road, north westwards for a distance of 26 metres

SCHEDULE 5 – RESIDENTS PARKING ONLY MONDAY TO SATURDAY INCLUSIVE

1. Primrose Street, Tonypany

- North eastern side from a point 7.5 metres north west of its junction with Derwydd Road, north westwards for a distance of 5 metres
- North eastern side from a point 17.5 metres north west of its junction with Derwydd Road, north westwards to the common boundary of No. 43 and 44, a distance of approximately 138.5 metres.
