Primrose Terrace, Y Porth

1. Y Ffordd Ddienw rhwng Teras Leslie a Chlos y Berllan, Porth

- a. Ar ochr orllewinol y ffordd gerbydau, o ochr ogledd-orllewinol ei chyffordd â Theras Leslie (ar ymyl dwyreiniol Rhif 56) i gyfeiriad cyffredinol y gogledd am 36.5 metr
- b. Ar ochr ddwyreiniol y ffordd gerbydau. O ochr dde-ddwyreiniol ei chyffordd â Theras Leslie i gyfeiriad cyffredinol y gogledd-orllewinol ac yna gogleddol am bellter o 30 metr

2. Primrose Terrace, Y Porth



(REVOCATION, ON STREET PARKING FOR SCHOOL BUSES AND WAITING RESTRICTIONS) ORDER 2025

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2, 4, 45, 46, 47, 49 and 53 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, the effect of which will be to:

1. Revoke the Traffic Regulation Order specified in Schedule 1
2. Designate the lengths of roads specified in Schedule 2 as On Street Parking Places for School Buses Only between 7.30am – 9:30am and 2:30pm – 4:30pm Monday to Friday only
3. Introduce waiting restrictions as specified in Schedule 3 and 4

SCHEDULE 1 – Revocation

The 'Rhondda Cynon Taff County Borough Council (Primrose Terrace, Llwynceilyn, Porth) (Waiting Restrictions) Order 2014' shall be revoked in its entirety.

SCHEDULE 2 - On Street Parking Places for School Buses Only
between 7.30am – 9:30am and 2:30pm – 4:30pm Monday to Friday only

Primrose Terrace, Porth

1. North-western side, from the common boundary of No. 57 and 58 Primrose Terrace, south westwards for a distance of 24 metres.

SCHEDULE 3 – Prohibition of Waiting At Any Time

1. The Unnamed Road between Leslie Terrace and Orchard Close, Porth

- a. Western side of the carriageway, from the north-western side of its junction with Leslie Terrace (on the eastern extent of No. 56) in a general northerly direction for 36.5 metres
- b. Eastern side of the carriageway. From the south-eastern side of its junction with Leslie Terrace in a general north westerly and then northerly direction for a distance of 30 metres

2. Primrose Terrace, Porth


- a. South-eastern side, from its junction with the Unnamed Road between Leslie Terrace and Orchard Close, north-eastwards to the common boundary of No. 59 and 60 Leslie Terrace, a distance of 15 metres
- b. North-western side, from a point 24 metres east of the common boundary of No. 57 and 58 Primrose Terrace in a general westerly and then northly direction to its junction with the Unnamed Road between Leslie Terrace and Orchard Close, a distance of approximately 7 metres

SCHEDULE 4 – Prohibition of Waiting
Monday to Friday 7:30am – 9:30am and 2:30pm – 4:30pm

Primrose Terrace, Porth

1. South-eastern side, from the common boundary of No. 59 and 60 Leslie Terrace to point opposite the common boundary of No. 57 and 58 Primrose Terrace. A distance of approximately 23 metres.
