

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act"), after consultation with the Chief Officer of Police in accordance with Section 23(2)(a) of the said Act proposes the following and of all other enabling powers, the effect of which will be to:

1. Establish a Zebra Pedestrian Crossing at the location specified in Schedule 1

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council propose under Sections 90A, 90C and 90G of the Highways Act 1980, the Highways (Road Humps) Regulations 1999 and the Highways (Traffic Calming) Regulations 1999 and all enabling powers, to implement the following traffic calming measures:

2. Full Width Flat Top Road Hump (6 metres wide, between 25mm – 100mm high), to be provided at, or within the vicinity of the location specified in Schedule 1

**SCHEDULE 1 – Pedestrian Crossing on a Full Width Flat Top Road Hump**

To be established at or within the vicinity of the following locations: -

1. **Tynant Road (B4595), Beddau** at a point opposite the common boundary of No. 23 and 25
2. **Parish Road (B4595), Beddau** at a point 21 metres south west from the centreline of its junction with Commercial Street
