

##### 1. Heol Llanwynno, Aberpennar

### (VARIATION AND WAITING RESTRICTIONS) ORDER 20\*\*

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Orders specified in Schedule 1
2. Introduce Waiting Restrictions on the lengths of roads specified in Schedule 2

#### SCHEDULE 1 – Variation

1. The "Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2012" shall be varied by the deletion of item (ii) from the following Order within the Schedule of Orders:

"Mid Glamorgan County Council (High Street, Llanwonno Road and Kingcraft Street, Mountain Ash) (Prohibition of Waiting) Order 1994"


2. The "Rhondda Cynon Taff County Borough Council (Various Streets in Rhondda Cynon Taff) (Review of Existing Traffic Regulation Orders 2012)" shall be varied by the removal of Schedule 2, Part 2, Item 25

#### SCHEDULE 2 – Prohibition of Waiting At Any Time

##### 1. Llanwonno Road, Mountain Ash

- a. The eastern side of Llanwonno Road, from a point 4.5 metres north of a point opposite the common boundary of No. 4 and 5 Llanwonno Road, in a southerly direction for a distance of approximately 85 metres.
- b. The western side, from a point 2 metres south of the common boundary of No. 6 and 7 Llanwonno Road, in a southerly direction for a distance of approximately 37 metres.
