

RHONDDA CYNON TAF

National Empty Homes Grant Scheme

Following on from the success of the regional Valleys Taskforce Scheme, in January 2023 the Welsh Government appointed Rhondda Cynon Taf County Borough Council as the Lead Authority to administer the delivery of a National Empty Homes Grant scheme. **£50M** has been invested by WG to bring long term empty properties (at least 12 months empty) back into use across Wales and up to **£25,000** is available per property for essential works.

Response and uptake to the scheme has been overwhelmingly positive. As at 31st March 2024;

Applications received of which 623 are valid.

Of the 623 valid applications, 133 are in RCT (21%)



244

applications have been approved with a commitment of £5.7M.

of which 66 are in RCT (27%) & £1.6M is apportioned to RCT (28%).



30

homes have been brought back into use with a spend of £604k.

Of which, 16 are in RCT (53%), & £336k is apportioned to RCT (56%)

This funding continues to bring empty homes across Wales, back into use and is helping to alleviate issues such as poor housing stock and eyesores in local communities.

Feedback:

Houses into Homes

Houses into Homes loans are being made available through the Houses into Homes Initiative to enable the renovation and improvement of single properties or the conversion of empty properties into a number of units, so that they are suitable for use as residential accommodation.

To date, Houses into Homes Loans have created 247 new units of accommodation for residents of RCT.

RCTCBC have also collaborated with Robert Owen Community Banking to offer an interest free loan to owner-occupiers. Loans are available for amounts between £1000 and £10,000, and are repayable up to a period of 5 years with no early repayment fees, and no set up fees. Robert Owen Community Banking Interest free loans have helped improve and upgrade 175 properties within RCT.

A further 8 properties have also benefitted from the Property Appreciation Loan, which is a loan to owner occupiers who are ineligible for the Home Improvement Loan. The loan is only repayable to the Authority on sale of the property.

In total, £7.175m of funding has been approved and paid via these schemes. The funding is due to continue until 2030 and information on the various grants and loans available can be found by following the link below.

Case Study:

Mid-Terraced Property in Rhondda Fawr, which had been empty for over 3 years and benefitted from Houses into Homes Loan of £25,000.

The total investment amounted to just over £40,000 and was completed within six months. The property has now been rented to a local family.

This is one of over 240 units of accommodation, which has been made available to residents of RCT under this scheme.

Housing Grants

Maintenance Repair Assistance Grants -

£575k

spent assisting private homeowners age 60 plus to carry out minor repairs to their homes.



Disabled Facilities Grants -

£6.6m

spent assisting RCT residents to live independently and remain safe in their own homes.



ENABLE - **£476k**

spent of Welsh Government funding to support palliative clients remain in their own homes and also carry out minor adaptations for 693 residents.

Affordable Housing

Clos Heddfan & Llys Ty Garth

The Clos Heddfan scheme located in Rhydyfelin has received a total investment of £6.7m to build 35 homes on the site. Hafod Housing received a £4m contribution for the scheme through the Social Housing Grant and funded the remainder themselves. The scheme is located on the old site of an RCTCBC office building which has been demolished in order to provide these affordable homes in the area.

The second Hafod Housing scheme, Llys Ty Garth is located in Taffs Well, 20 homes have been built by M J Cosgrove for the £3.4m scheme. £2.1m of funding was received through the Social Housing Grant while the rest was funded by Hafod.



Clr Bob Harris, Cabinet Member for Public Health and Communities, said:

"Thank you to Hafod for the invitation to visit Clos Heddfan and Llys Ty Garth. It was great to be shown around the Heddfan development by Hafod and the directors of ASD, the work that has completed on the site is exceptional and I'm sure residents will be very happy to move into these homes."

"It was also great to visit Llys Ty Garth in Taffs Well and speak to the residents who moved have moved in. It was great to hear that they're all happy and have been able to build a tightknit community."

HomeStep

The HomeStep scheme is operated by RCT Council and is delivered in partnership with private developers to help first time buyers get on to the property ladder by offering brand new homes at an affordable price.

HomeStep enables eligible applicants to buy a home at a percentage of its full market value (usually 70%) with the Council retaining the remaining share of the freehold value of the house.

Current and upcoming developments include:

- **Coed Derw development in Llantwit Fardre by Bellway Homes**
- **Michaels Grove development in Llanharan by Persimmon Homes**
- **Cwm Heulwen development in Aberdare by Davies Homes**

Heat & Save

The Heat & Save team have been continuing to support households to help alleviate fuel poverty. The team has been attending a number of community engagement events and establishing closer working relationships with other agencies such as Citizen's Advice.

The aftermath of the Cost of living & Energy Crisis as well as Covid-19 has shown a greater increase in households with complex energy related problems needing further assistance. It is widely recognised that one single approach will not mitigate the impact of fuel poverty and the Council is passionate by providing an holistic service through the Heat & Save Hub.

Heat & Save not only enables energy efficiency improvements in homes through the ongoing grants and schemes available it also provides support and referrals for residents to access other assistance such as fuel bank vouchers, welfare benefits advice and energy debts.



Heating Grant & Solar PV Grants

Both grants which are funded by Shared Prosperity Fund have remained popular and to date over 100 Solar PV grants and over 210 heating grants have been provided to residents across RCT making their homes more energy efficient and reducing energy bills. There has been a 60% increase in the number of households receiving assistance from the heating grant compared to the previous year. This has resulted in over 310 SPF grants being delivered, totalling circa £500k of investment for RCT residents.

ECO 4 Flex

At the end of November 2023 the Council also launched it's ECO 4 Flex scheme, which is a national Government funded Scheme funded by energy companies which is delivered via installers. Although it is considered a private market scheme the Council has been utilising it's enabling role to administer the applications for the scheme and lever this external funding into the RCT area.

ECO 4 is a multi measure scheme assisting homes with low energy performance. To date we have received 41 applications and numbers continue to rise.

Case Study:

Mr Chick

Mr Chick received an SPF funded grant for a Solar PV which helped him expand his existing solar panels with solar edge optimisers. This then raised the energy performance of his home from an EPC rating of C to a rating of A which is the highest level of energy performance that can be achieved. Mr Chick informed us that from calculations on his energy bills he is expecting to save around £650 per year.

This highlights an example of resident who wants to generate cleaner renewable energy and make significant savings to their household bills.
