Effaith y Gorchymyn fydd: -

**1. Cau Ffordd**

Miskin Road, Aberpennar o'i chyffordd â Bailey Street hyd i'w chyffordd â Glyngwyn Street a Penrhiwceiber Road

**Llwybr amgen:** O ochr ogleddol y ffordd sydd wedi'i chau, gyrrwch drwy Bailey Street a Glyngwyn Street i ochr ddeheuol y ffordd sydd wedi'i chau.

**2. Dim aros ar unrhyw adeg dros dro**

a. Glyngwyn Street, dwy ochr hyd cyfan y stryd

b. Bailey Street, ochr dde-ddwyreiniol, o'i chyffordd â Glyngwyn Street i'w chyffordd â Miskin Road

**Noder** Bydd y cyfyngiadau aros dros dro yn Rhan a, Glyngwyn Street, yn cael eu cyflwyno mewn pedair rhan lai. Fodd bynnag, os nad yw'r trefniant yma yn ddigon i gynnal llif y traffig, mae gan y Cyngor yr hawl i gyflwyno cyfyngiadau pellach os oes angen

Mae angen y cyfyngiad fel bydd modd cynnal y gwaith ar y ffordd neu yn ei hymyl.

Byddai'r Gorchymyn yn dod i rym o 1 Gorffennaf 2018 i 30 Awst 2019, neu hyd nes i'r gwaith gael ei gwblhau.

Fydd **DIM** mynediad i gerbydau gwasanaethau brys nac i gerddwyr.

(TEMPORARY TRAFFIC RESTRICTIONS) ORDER 2018**

The effect of the Order will be to: -

**1. Road Closure**

Miskin Road, Mountain Ash from its junction with Bailey Street to its junction with Glyngwyn Street and Penrhiwceiber Road

**Alternative Route:** From the northern side of the closure, proceed via Bailey Street and Glyngwyn Street to the southern side of the closure.

**2. Temporary Prohibition of Waiting At Any Time**

a. Glyngwyn Street, both sides for its entire length

b. Bailey Street, south eastern side, from its junction with Glyngwyn Street to its junction with Miskin Road

**NB** The temporary waiting restrictions in Part a, Glyngwyn Street, will be introduced in four smaller sections. However, should it become apparent that this arrangement is not sufficient to maintain traffic flow, the Council reserves the right to introduce further lengths of restrictions as and when required

The restriction is necessary to enable works to be executed on or near the road.

The Order would come into force from 1st July 2018 to 30th August 2019 or until such time as the works have been completed

Access **WILL NOT** be maintained for pedestrians or emergency service vehicles
