GORCHYMYN (CAU'R Ffordd Dros Dro) 2018

DYMA HYSBYSIAD bod Cyngor Bwrdeistref Sirol Rhondda Cynon Taf yn bwriadu gwneud Gorchymyn, ar ôl o leiaf 7 diwrnod o ddyddiad yr Hysbysiad yma, o dan Adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984, fel y'i diwygiwyd gan Ddeddf Traffig Ffyrdd (Cyfyngiadau Dros Dro) 1991, a fydd yn para ddeunaw mis ar y mwyaf.

Effaith y Gorchymyn fydd gwahardd dros dro unrhyw berson rhag achosi i unrhyw gerbyd deithio ar hyd Pont Sherwood Street o'i chyffordd â Pontrhondda Road tua'r gogledd-ddwyrain am bellter o 40 metr.

Mae disgwyl i'r Gorchymyn fod mewn grym o 3 Ebrill 2018 tan 16 Ebrill 2018, ac o 7 Mai 2018 tan 28 Ionawr 2019 neu hyd nes i'r gwaith gael ei orffen.

Mae angen y cyfyngiad fel bydd modd cynnal y gwaith ar y ffordd neu yn ei hymyl.

Fydd DIM mynediad i gerbydau gwasanaethau brys.

Bydd mynediad ar gael i gerddwyr yn ystod cyfnod 1 y gwaith.

Mae llwybr arall i gerbydau fel a ganlyn:

O ochr ddwyreiniol y ffordd sydd wedi'i chau, ewch ar hyd Sherwood Street, Partridge Road, Princess Louise Road, Oakfield Terrace a Sherwood Street i ochr orllewinol y ffordd sydd wedi'i chau.

Yn achos gyrwyr sy'n teithio i'r cyfeiriad arall, bydd eisiau dilyn y cyfarwyddiadau uchod yn y drefn wrthol.

(TEMPORARY ROAD CLOSURE) ORDER 2018

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily prohibit any person from causing any vehicle to proceed along Sherwood Street Bridge from its junction with Pontrhondda Road, north eastwards for a distance of 40 m.

It is expected to be operative from 3rd April 2018 to 16th April 2018 and from 7th May 2018 to 28th January 2019 or until such time as the works is completed

The restriction is necessary to enable works to be carried out on or near the road.

Access will NOT be maintained for emergency vehicles.

Access will be maintained for pedestrians during phase 1 of the closure.

The alternative route for vehicles is as follows:

From the eastern side of the closure, proceed via Sherwood Street, Partridge Road, Princess Louise Road, Oakfield Terrace and Sherwood Street to the western side of the closure.

For vehicles travelling in the opposite direction, reverse the directions given above.
