**(LLWYNYPYA ROAD, TONYPANDY)**

**GORCHYMYN (CAU FFYRDD DROS DRO) 2018**

**DYMA HYSBYSIAD** bod Cyngor Bwrdeistref Sirol Rhondda Cynon Taf yn bwriadu gwneud Gorchymyn, ar ôl o leiaf 7 diwrnod o ddyddiad yr Hysbysiad yma, o dan Adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984, fel y'i diwygiwyd gan Ddeddf Traffig Ffyrdd (Cyfyngiadau Dros Dro) 1991, a fydd yn para ddeunaw mis ar y mwyaf.

Effaith y Gorchymyn fydd gwahardd dros dro unrhyw berson rhag achosi i unrhyw gerbyd deithio ar hyd Llwynypia Road, o'i chyffordd â Ffordd yr A4058 hyd at ei chyffordd ag Institute Place, ac ar hyd Institute Place, o'i chyffordd â Llwynypia Road, tua'r de-orllewin am bellter o 20 metr.

Mae angen y cyfyngiad fel bydd modd cynnal y gwaith ar y ffordd neu yn ei hymyl.

Mae disgwyl i'r Gorchymyn fod mewn grym o 3 Ebrill 2018 tan 15 Ebrill 2018, neu hyd nes i'r gwaith gael ei offen.

Fydd **DIM** mynediad ar gael i gerbydau'r gwasanaethau brys.

Bydd mynediad ar gael i gerddwyr.

Pan fydd y ffordd ar gau, bydd llwybr arall i gerbydau fel a ganlyn:

O ochr ddeheuol y ffordd sydd ar gau, ewch trwy Llwynypia Road, Court Street, Ffordd Ddienw i ochr Rhif 34 Court Road, Ffordd fynedfa anhysbys i swyddfeydd y cyngor, Cylchfan Cwm Clydach, A4119 Cylchfan Tonypany a'r A4058 i ochr ogleddol y ffordd sydd ar gau.

Yn achos gyrwyr sy'n teithio i'r cyfeiriad arall, bydd eisiau dilyn y cyfarwyddiadau uchod yn y drefn wrthol.

**(TEMPORARY ROAD CLOSURE) ORDER 2018**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily prohibit any person from causing any vehicle to proceed along Llwynypia Road, from its junction with Route A4058 to its junction with Institute Place, and Institute Place, from its junction with Llwynypia Road, south westwards for a distance of 20 metres

The restriction is necessary to enable works to be carried out on or near the road

The Order is expected to be in operation from 3rd April 2018 to 15th April 2018 or until the works are completed.

Access will **NOT** be maintained for emergency service vehicles

Access will be maintained for pedestrians

During the period of the closure the alternative routes will be as follows:-

From the southern side of the closure, proceed via Llwynypia Road, Court Street, Unnamed Road to the side of No. 34 Court Road, Unnamed access road to the council offices, Clydach Vale Roundabout, A4119 Tonypany Roundabout and A4058 to the northern side of the closure.

For vehicles travelling in the opposite direction, reverse the directions given above.
