**(TEMPORARY ROAD CLOSURE) ORDER 2018**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily prohibit any person from causing any vehicle to proceed along the A4061 Bwlch-y-Clawdd Road.

It is expected to be operative from 3rd April 2018 to 10th April 2018 or until such time as the works is completed

The restriction is necessary to enable works to be carried out on or near the road.

Access will be maintained for emergency vehicles and pedestrians

The alternative route for vehicles is as follows:

From the western side of the closure, proceed via A4061 (Nant-y-Moel) to Blackmill, route A4093, route A4119, route A4058 to Treorchy, and route A4061 to the eastern side of the closure.

From the eastern side of the closure, reverse the directions given above
