Effaith y Gorchymyn fydd:-

1. Gwahardd dros dro unrhyw berson rhag achosi i unrhyw gerbyd deithio ar hyd ffordd Dunraven Street o'i chyffordd ddeheuol â Gelli Road am bellter o 195 o fetrau tua'r gogledd i'w chyffordd ogleddol â Gelli Road
2. Atal Erthygl 3 o Orchymyn "Cyngor Bwrdeistref Sirol Rhondda Cynon Taf (Dunraven Street a De Winton Street, Tonypandy) (Amrywiad, Gwahardd Aros a Gwahardd Mynediad) 2000" dros dro dros gyfnod y Gorchymyn er mwyn caniatáu mynediad i Dunraven Street i gerbydau adeiladu traffig a masnachwyr (ar gyfer llwytho a dadlwytho yn unig).
3. Atal Atodlen 5 o Orchymyn "Cyngor Bwrdeistref Sirol Rhondda Cynon Taf (Adfywio Canol Tref Tonypandy) (Amrywio, Dirymu, Ardal Cerddwyr, Traffig Un Ffordd, Gwahardd Traffig Drwedd, Gwahardd Mynediad, Gwahardd Troi i'r dde a Gwahardd Llwytho a Dadlwytho 1998" ar hyd y Gorchymyn dros dro dros gyfnod y Gorchymyn er mwyn caniatáu mynediad o gyfeiriad y de i Dunraven Street i gerbydau adeiladu traffig a masnachwyr (ar gyfer llwytho a dadlwytho yn unig).

Mae angen y cyfyngiad fel bydd modd cynnal y gwaith ar y ffordd neu yn ei hymyl.

Byddai'r Gorchymyn yn dod i rym o 7:00am ar 18fed Mehefin 2018 i 7:00am ar 6ed Hydref 2018, neu hyd nes i'r gwaith gael ei gwblhau.

Bydd mynediad ar gael i gerddwyr ac i gerbydau'r gwasanaethau brys.

Bydd mynediad yn cael ei gynnal ar gyfer busnesau trwy gydol y gwaith i lwytho a dadlwytho yn ystod oriau gwaith yn amodol ar drafod hynny gyda'r busnesau lleol.

**RHONDDA CYNON TAFF COUNTY BOROUGH COUNCIL

TEMPORARY ROAD CLOSURE ORDER 2018**

The effect of the Order will be to:-

1. Temporarily prohibit any person from causing any vehicle to proceed along Dunraven Street from its southern junction with Gelli Road for a distance of 195 metres o its northern junction with Gelli Road
2. Temporarily suspend Article 3 of the "Rhondda Cynon Taff County Borough Council (Dunraven Street and De Winton Street, Tonypandy) (Variation, Prohibition of Waiting and Prohibition of Entry) Order 2000" for the duration of the temporary Order to allow vehicular access for construction traffic and traders (for loading and unloading only) traffic to Dunraven Street.
3. Temporarily suspend Schedule 5 of the "Rhondda Cynon Taff County Borough Council (Tonypandy Town Centre Regeneration) (Variation, Revocation, Pedestrianised Area, One Way Traffic, Prohibition of Through Traffic, Prohibition of Entry, Prohibition of Right Hand Turn and Prohibition of Loading and Unloading Order 1998" for the duration of the temporary Order to allow vehicular access for construction traffic and traders (for loading and unloading only) to Dunraven Street via the southbound approach

The restriction is necessary to enable works to be executed on or near the road.

The Order would come into force from 7:00am on 18th June 2018 to 7:00am on 6th October 2018 or until such time as the works have been completed

Access will be maintained for pedestrians and emergency service vehicles

Access will be maintained for the business premises for the duration of the works for loading and unloading during working hours subject to co-ordination with the local businesses
