PROPOSED AMENDMENTS TO WAITING RESTRICTIONS - POPLAR ROAD, RHYDYFELIN

As you may be aware, the Council has previously consulted on proposals to amend the waiting restrictions in the lay-by on the south western side of Poplar Road.

The existing Prohibition of Waiting Monday to Friday 8:30am - 4:30pm will be replaced with a section of Limited Waiting Monday to Friday 8:30am - 4:30pm 2 hours no return within 4 hours. The Limited waiting restriction is intended to improve parking opportunities for visitors to the Rhydyfelin Library site.

Details of the proposals are shown on the attached drawing IF042-1, which may also be viewed at www.rctcbc.gov.uk/traffic

The next stage is a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any comments they may have.
