PROPOSED AMENDMENTS TO WAITING RESTRICTIONS - POPLAR ROAD, RHYDYFELIN

The Council has developed proposals to amend the waiting restrictions in the lay-by on the south western side of Poplar Road.

The existing Prohibition of Waiting Monday to Friday 8:30am - 4:30pm will be replaced with a section of Limited Waiting Monday to Friday 8:30am - 4:30pm 2 hours no return within 4 hours. The Limited waiting restriction is intended to improve parking opportunities for visitors to the Rhydyfelin Library site.
