O ochr dde-orllewinol y ffordd sy'n cael ei chau, ewch ar hyd Pound Farm Lane, Cylchfan Ton-teg, A473 (Tonteg Road), Severn Road, Taffs Mead Road, Gwaelod-y-Garth Road a Maesmawr Road i gyrraedd ochr ogledd-ddwyreiniol y ffordd sy'n cael ei chau.

O ochr ogledd-ddwyreiniol y ffordd sy'n cael ei chau, ewch ar hyd Maesmawr Road, Gwaelod-y-Garth Road, A473 (Tonteg Road), Cylchfan Ton-teg a Pound Farm Lane i gyrraedd ochr dde-orllewinol y ffordd sy'n cael ei chau.

Bydd y Gorchymyn hwn mewn grym o 9 Hydref 2017.

Mae modd edrych ar gopi o'r dogfennau perthnasol ynglŷn â'r Gorchymyn yn ystod oriau swyddfa arferol ym Mhrif Swyddfeydd Cyngor Bwrdeistref Sirol Rhondda Cynon Taf, Y Pafiliynau, Parc Hen Lofa'r Cambrian, Cwm Clydach, Tonypandy CF40 2XX ac yn Llyfrgell Pentre'r Eglwys, Campws Cymuned Gartholwg, oddi ar Heol Illtud Sant, Pentre'r Eglwys, Pontypridd CF38 1RQ tan 9 Ebrill 2019.

Bydd Cyngor Bwrdeistref Sirol Rhondda Cynon Taf yn ystyried maes o law a fydd darpariaethau'r Gorchymyn yn parhau mewn grym am gyfod amhenadol. Rhaid anfon gwrthwynebiadau i'r cynnig mewn ysgrifén, gyda'r rhesymau dros eu gwneud, at y Rheolwr Traffig, Tŷ Sardis, Heol Sardis, Pontypridd CF37 1DU o fewn chwe mis i 9 Hydref 2017.

Gall Cyngor Bwrdeistref Sirol Rhondda Cynon Taf ddarparu ar gyfer atal a diwygio'r gorchymyn, neu ran ohono, tra bydd mewn grym os yw'n ymddangos ei fod yn hanfodol i alluogi llif traffig hwylus a diogel neu, fel arall, i ddarparu cyfleusterau parcio addas a digonol ar y briffordd neu er mwyn diogelu neu wella amwynderau'r ardal y mae unrhyw ffordd sy'n cael ei heffeithio gan y gorchymyn yn rhedeg trwyddi.

Caiff unrhyw berson wneud cais i'r Uchel Lys at ddibenion cwestiynu diliysrwydd y Gorchymyn, neu ddiliysrwydd unrhyw ddarpariaeth ynddo, ar y sail nad yw'n unol â'r pwerau o dan Ddeddf Rheoleiddio Traffig Ffyrdd 1984, neu ar y sail nad yw'n cydymffurfio â gofyniad yn y Ddeddf honno neu ag offeryn sydd wedi'i wneud o dani mewn perthynas â'r Gorchymyn, os yw'n dymuno gwneud hynny. Rhaid gwneud hynny o fewn chwe wythnos i 9 Hydref 2017.

(EXPERIMENTAL PROHIBITION OF THROUGH TRAFFIC) ORDER 2017

Notice is hereby given that on the 25th September 2017 the Rhondda Cynon Taff County Borough Council made an order under Sections 9 and 10 of the Road Traffic Regulation Act 1984 the effect of which is to experimentally for a period of not exceeding eighteen months: -

Prohibit any person from causing any vehicle proceeding along either lengths of road described in Column 1 below to enter the lengths of road described in relation to those roads in Column 2

Column 1	Column 2
Unnamed Road leading to Maesmawr Farm (Pound Farm Lane)	Maesmawr Road
Maesmawr Road	Unnamed Road leading to Maesmawr Farm (Pound Farm Lane)

The alternative route for vehicles is as follows:

From the south western side of the closure, proceed via Pound Farm Lane, Tonteg Roundabout, A473 (Tonteg Road), Severn Road, Taffs Mead Road, Gwaelod-y-Garth Road and Maesmawr Road to the north eastern side of the closure.

From the north eastern side of the closure, proceed via Maesmawr Road, Gwaelod-y-Garth Road, A473 (Tonteg Road), Tonteg Roundabout and Pound Farm Lane to the south western side of the closure.

This order shall be in operation from 9th October 2017.

A copy of the relevant documents to which the Order relates may be inspected during normal office hours at the Principal Offices of the Rhondda Cynon Taff County Borough Council, The Pavilions, Cambrian Park, Clydach Vale, Tonypandy CF40 2XX and Church Village Library, Garth Olwg Community Campus, off St Illtyd's Road, Church village, Pontypridd, CF38 1RQ until 9th April 2019.

The Rhondda Cynon Taff County Borough Council shall be considering in due course whether the provisions of the order shall continue in force indefinitely. Objections to the proposal, together with the grounds on which they are made must be sent in writing to the Traffic Manager, Sardis House, Sardis Road, Pontypridd, CF37 1DU within six months from the 9th October 2017.

The Rhondda Cynon Taff County Borough Council may provide for the suspension and modification of the order or part thereof, while it is in force if it appears that it is essential in the interest of the expeditious convenient and safe movement of traffic or else the provision of suitable and adequate parking facilities in the highway or for preserving or improving the amenities of the area through which any road affected by the order runs.

Any person wishing to question the validity of the Order or of any provision contained in it on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act, 1984 or on the grounds that any requirement of that Act or of any instrument made under it had not been complied with in relation to the Order, may within six weeks from 9th October 2017 apply to the High Court for this purpose.
