**Proposed No Waiting at Any Time (Double Yellow Lines)
Salem Lane, Church Village - Residents Consultation**

Following concerns regarding dangerous / obstructive parking, the council are currently developing proposals to introduced waiting restrictions (double yellow lines) in the vicinity of Salem Lane, Church Village.

The council is writing to all affected residents to advise of the proposals and provide the opportunity for residents to submit their observations and or make comment.
