Dear Sir / Madam,

As part of the construction of the Mountain Ash Cross Valley Link Road it will be necessary to both introduce new traffic regulation orders and remove some existing ones.

This will include;

- Introducing No Waiting at Any time restrictions on Miskin Road, Glyngwyn Street, Jones Street and the Cross Valley Link Road.
- Introducing a Prohibition of Driving at the junction of Glyngwyn Street and Bush Road.
- Establish Pedestrian Crossings at the junction of Miskin Road and the Cross Valley Link Road.
- Removing the existing one way system in Miskin Road to allow two way traffic
