### **CYFYNGIADAU ARFAETHEDIG – DIM AROS AR UNRHYW ADEG – SCHOOL STREET, TREWILIAM**

Mae'n bosibl eich bod chi eisoes yn gwybod bod y Cyngor wedi cynnal cyfnod ymgynghori yn ddiweddar ynglŷn â'r cynllun arfaethedig i gyflwyno llinellau melyn dwbl yn y lleoliad sydd wedi'i nodi uchod.

Cafodd 26 o lythyron eu hanfon a daeth 2 o ymatebion yn ôl - oll yn erbyn y cynllun. Mae'r sylwadau wedi cael eu trafod a'r penderfyniad oedd peidio â derbyn y gwrthwynebiadau am y rhesymau canlynol:

- *Byddwn i'n awgrymu'n gryf y dylid cyflwyno cynllun parcio cyn cyflwyno unrhyw waharddiad parcio ychwanegol.*

Mae cyflwyno cynllun parcio i Drigolion y tu hwnt i gylch gwaith y cynllun yma.

- *Does dim digon o fannau parcio yn y stryd fel y mae - byddai cael gwared ar fannau parcio eraill yn gwaethygu'r sefyllfa.*

Mae llinellau melyn dwbl yn cael eu cynnig ar gyfer rhesymau diogelwch ar y ffyrdd. Y briffordd darparu ar gyfer y daith o gerbydau ac ni allwn eu hystyried fel darpariaeth ar gyfer eiddo parcio.

**PROPOSED PROHIBITION OF WAITING AT ANY TIME - SCHOOL STREET,  
WILLIAMSTOWN**

As you may be aware, the council has previously consulted on proposals to introduce double yellow lines at the above location.

26 letters were sent out and 2 replies were received, both of which objected to the scheme. The comments were considered and it has been decided to not accept the objections for the following reasons:

- *I would strongly suggest the introduction of a parking scheme prior to the introduction of any extra parking prohibition*

The introduction of Residents parking is outside the remit of this scheme

- *There are not enough car spaces to park in the street as it is without taking away any more.*

Double yellow lines are being proposed for road safety reasons. The highway is provided for the passage of vehicles and cannot be considered as parking provision for properties.

- *There is plenty of room for the buses to swing around like they have done for years. All you have to do is remove the signpost situated outside no 10 and there is no problem at all.*

The scheme has been developed in response to complaints from the bus company that parking at the junction is obstructive. The existing signpost outside no. 10 School Street has been set back from the carriageway and has no detrimental impact on vehicles entering the street.

Details of these proposals are shown on the attached drawing **P049-1**

The next stage is a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any concerns they may have. If you wish to object to the proposals, you should do so in writing by **26th April 2018**, to the Traffic Manager, Traffic Management, Sardis House, Sardis Road, Pontypridd, CF37 1DU or alternatively by email at [trafficservices@rctcbc.gov.uk](mailto:trafficservices@rctcbc.gov.uk)
