PROPOSED 20 MPH SPEED LIMIT ZONE RESTRICTIONS STATION ROAD AND PENCAI TERRACE TREORCHY

As part of a safe routes in communities scheme around Treorchy Comprehensive School, proposals have been developed to introduce 20 mph Speed Limit Zone Restrictions in Station Road and Pencai Terrace Treorchy.

The existing Zebra crossing is to be re-located and placed on a raised plateau, the existing bus stop is also to be re-located along with a new shelter and two additional full width road humps are to be introduced in Station Road as indicated on attached Consultation Drawing G-12-1.

Currently the area is subject to 30 mph however, it is considered that a 20 mph speed limit will be a more appropriate speed limit for the community and the environment.

I shall be pleased to receive your observations on this proposal. For your convenience, a pro forma and postage paid addressed envelope is enclosed. Alternatively you may wish to respond by e-mail to trafficervices@rctcbc.gov.uk Responses should be returned with your observations by Friday 30/03/2018. If I do not hear from you by that date, I shall assume that you have no objections to the proposal.

Any comments received will help us decide whether to make changes to the proposals and all observations relating to the scheme will be taken into consideration, however the Council will make no formal response to your comments at this stage. A further consultation exercise is given at Public Notice Stage, when you will have a formal opportunity to make observations on the proposals.

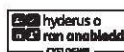
