
Mae'n bosibl eich bod chi eisoes yn gwybod bod y Cyngor wedi cynnal cyfnod ymgynghori ynglŷn â'r cynllun arfaethedig i gyflwyno mesurau diogelwch yn y lleoliad sydd wedi'i nodi uchod rhwng 24 Mai 2018 a 14 Mehefin 2018.

Cafodd 34 o lythyrau ynghylch y cynllun eu hanfon at breswylwyr a busnesau, a chawson ni 11 ymateb. Roedd 6 ymateb o blaid y cynllun a 4 ymateb yn erbyn y cynllun. Doedd 1 ymateb ddim o blaid nac yn erbyn y cynllun.

RE: PROPOSED SPEED LIMIT CHANGES, ZEBRA CROSSING WITH BUILD OUTS, CHANGES TO BUS STOP LOCATIONS AND DOUBLE YELLOW LINES - PENRHIWFER ROAD AND BRYN RHEDYN, TONYREFAIL.


As you may be aware, the Council has previously consulted on proposals to introduce safety measures to the above location between 24th May 2018 and 14th June 2018.

34 letters with plans were delivered to residents and businesses fronting the scheme, 11 responses were received in total with 6 supporting the scheme, 4 opposing the scheme and a further 1 neither supports or opposes the scheme.

The scheme has been modified slightly based on the responses received. The 40mph speed limit buffer zone is to be extended and the bus stop locations are to be moved and the bus stop build out will no longer to be installed. The modified proposals are shown on the attached drawing **P-060 / G-12- 4**.

The next stage is a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any concerns they may have. If you wish to object to the proposals, you should do so in writing by 27th July 2018, to the Traffic Manager, Traffic Management, Sardis House, Sardis Road, Pontypridd, CF37 1DU or alternatively by email at trafficservices@rctcbc.gov.uk.
