

Re: Ystrad Rhondda Community Route – 20mph Speed Limit and Traffic Calming Measures, Pontrhondda Road and Pontrhondda Avenue, Llwynypia.

As you may be aware, the council has previously consulted on proposals to introduce road safety measures in Pontrhondda Road and Pontrhondda Avenue, Llwynypia.


75 letters were sent out and 17 replies received. 10 in support and 6 against. 1 respondent was neutral on the proposals and felt parking around the school was a bigger concern for the residents. 3 supported the introduction of a 20mph speed limit but not traffic calming measures.

Following the consultation, the scheme has not been amended from that which was previously consulted upon as the proposed 20mph speed limit and traffic calming measures have been broadly welcomed.

Details of the proposals are shown on the attached drawing **P064-01**

The next stage is a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any concerns they may have. If you wish to object to the proposals, you should do so in writing by 27th February 2018, to the Traffic Manager, Traffic Management, Sardis House, Sardis Road, Pontypridd, CF37 1DU or alternatively by email at trafficservices@rctcbc.gov.uk.
