

**20mph Speed Limit, Pedestrian Crossing Improvements and Traffic Calming, Porth - Safer Routes in the Community.**

Rhondda Cynon Taf County Borough Council has developed proposals to introduce a 20mph Speed Limit on Rheola Road ( that includes short sections of lower Cemetery Road and Aber-Rhondda Road ), Porth, The proposal forms part of the Porth Safer Routes in the Community. As part of the scheme, proposals will also include traffic calming features and improvements to several crossings.


The scheme comprises a 20mph speed limit change from the current 30mph speed limit ( area indicated in blue on the attached drawing ) with new 20mph signing installed with red surfacing at the new speed limit gateway signs ( shown in red ). Details of the proposals are shown on the attached drawing **P071 / 105**.
