

As you may be aware, the Council has previously consulted on proposals to make changes to Tonypandy Town Centre on that part of Dunraven Street that is presently pedestrianised.

Letters were delivered to residents and businesses with an invitation to attend a Public Exhibition as part of an informal consultation that took place in Tonypandy where the scheme proposals could be viewed and comments could be left regarding the proposals.


76 responses were received, 58 in support of the proposals and 18 objecting to the proposals.

Details of the proposals are shown on the attached drawing **P072-01**

Following the consultation, it has been agreed that the scheme should proceed as advertised.

The next stage is a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any concerns they may have.
