DYMA HYSBYSIAD bod Cyngor Bwrdeistref Sirol Rhondda Cynon Taf yn bwriadu gwneud Gorchymyn, ar ôl o leiaf 7 diwrnod o ddyddiad yr Hysbysiad yma, o dan Adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984, fel y'i diwygiwyd gan Ddeddf Traffig Ffyrdd (Cyfyngiadau Dros Dro) 1991, a fydd yn para deunaw mis ar y mwyaf.

Effaith y Gorchymyn fydd cau Stryd Fawr Llantrisant dros dro, o'i chyffordd ag Erw Hir / Roam Road tua'r gogledd am bellter o 80 metr.

Mae angen cau'r rhan yma o'r ffordd fel bod modd cynnal gwaith arni neu yn ei hymyl.

Bydd y ffordd ar gau ddydd Sul 6 Ionawr 2019 neu hyd nes bydd y gwaith wedi'i gwblhau.

Bydd mynediad ar gael i gerbydau'r gwasanaethau brys.

Fydd mynediad DDIM ar gael i gerddwyr.

Bydd llwybr amgen i gerbydau yn mynd o ochr ogleddol y ffordd sydd wedi'i chau, trwy Newbridge Road, Ffordd Llantrisant, Heol Gwaunmeisgyn, Tynant Road, Parish Road, Woodlands, ffordd osgoi'r A473 Pentre'r Eglwys, yr A4119, Talbot Road a Stryd Fawr i ochr ddeheuol y ffordd sydd wedi'i chau.

Ar gyfer cerbydau sy'n teithio i'r cyfeiriad arall, dilynwch y cyfeiriadau uchod i'r gwrthwyneb.

(TEMPORARY ROAD CLOSURE) ORDER 2018

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close High Street, Llantrisant, from its junction with Erw Hir / Roam Road, northwards for a distance of 80 metres

The restriction is necessary to enable works to be carried out on or near the roads

The closure is expected to be in operation on Sunday 6th January 2019 or until such time as the works have been completed.

Access will be maintained for emergency service vehicles

Access will NOT be maintained for pedestrians

The alternative route for vehicles is from the northern side of the closure proceed via Newbridge Road, Llantrisant Road, Gwaunmiskin Road, Tynant Road, Parish Road, Woodlands, A473 Church Village bypass, A4119, Talbot Road and High Street to the southern side of the closure.

For vehicles travelling in the opposite direction, reverse the directions given above.
