- iv. Y ffordd ddi-enw rhwng 11 Heol Pontypridd a 66 Hannah Street



**(TEMPORARY ROAD CLOSURE) ORDER 2019**

Whereas it will be necessary for the prevention of obstruction and accidents to close public highways, notice is hereby given that the Rhondda Cynon Taff County Borough Council have made an order under Section 21 of the Town Police Clauses Act 1847 closing the lengths of roads specified below to vehicular traffic on Monday 29th April 2019 between the hours of 7:00am to 10:00pm

The restriction is necessary to facilitate filming on the highway

**Road Closure**

- i. Hannah Street, Porth, from its junction with West Taff Street to its junction with Station Street
- ii. The Unnamed Road between 29a Pontypridd Road and 44 Hannah Street
- iii. The Unnamed Road between 27 West Taff Street and 16 Hannah Street
- iv. The Unnamed Road between 11 Pontypridd Road and 66 Hannah Street


**Alternative Route** – from the southern side of the closure, proceed via Pontypridd Road and Station Street to the northern side of the closure

Access for pedestrians and emergency services vehicles will be maintained at all times

Access will be maintained for delivery vehicles
