
Mae angen y cyfyngiad fel bydd modd cynnal y gwaith ar y ffordd neu yn ei hymyl.

(TEMPORARY ROAD CLOSURE) ORDER 2019

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close Lon Las to End South, Railway Bridge, approximately 45 metres south west from its junction with Lon Las


The restriction is necessary to enable works to be executed on or near the road.

It is expected to be in operation from 2300 hours on 8th July to 0600 hours on 9th July 2019 or until such time as the works have been completed

No diversion available – No through road

Access for pedestrians and emergency services will be maintained
