Effaith y Gorchymyn fydd cau Stryd Fawr Llantrisant (B4595) dros dro, o'i chyffordd â Stryd y Castell tua'r gogledd-ddwyrain am bellter o thua 80 metr.

Mae angen y cyfyngiad fel bydd modd cynnal gwaith ar y ffordd neu yn ei hymyl.



(TEMPORARY ROAD CLOSURE) ORDER 2019

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council have made an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close High Street (B4595), Llantrisant between its junction with Castle Street and Roam Road in a north-easterly direction for a distance of approximately 80 metres

The restriction is necessary to enable works to be executed on or near the road


The closure is expected to be in force from 08:00 – 18:00 on 21st July 2019 or until such time as the works have been completed.

Alternative Route – from the northern side of the said closure proceed via Commercial Street (B4595), High Street (B4595), Heol-Y-Sarn, Ely Valley Road (A4119) and Talbot Road

For vehicles travelling in the opposite direction, reverse the directions given above.

Access will be maintained for pedestrians and emergency service vehicles
