Ar gyfer cerbydau sy'n teithio i'r cyfeiriad arall, newidiwch drefn yr uchod.


Mae angen y cyfyngiad fel bydd modd cynnal y gwaith ar y ffordd neu yn ei hymyl.

(TEMPORARY ROAD CLOSURE) ORDER 2019

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close Tesco Roundabout, Upper Boat

Alternative Route – from the northern side of the closure proceed via Gelli Hirion Industrial Estate, Dynea Road, Williams Place, Cardiff Road (A4054), Upper Boat to Tesco to the southern side of the closure

For vehicles travelling in the opposite direction, reverse the directions given above.


The restriction is necessary to enable works to be executed on or near the road

The closure is expected to be in operation during the following dates and time or until such time as the works have been completed:-

- i. 2000 hours on 2nd June to 0600 hours on 3rd June 2019
- ii. 2000 hours on 9th June to 0600 hours on 10th June 2019

Access will **NOT** be maintained for emergency service vehicles or pedestrians
