**DYMA HYSBYSIAD** bod Cyngor Bwrdeistref Sirol Rhondda Cynon Taf yn bwriadu gwneud Gorchymyn, ar ôl o leiaf 7 diwrnod o ddyddiad yr Hysbysiad yma, o dan Adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984, fel y'i diwygiwyd gan Ddeddf Traffig Ffyrdd (Cyfyngiadau Dros Dro) 1991, a fydd yn para deunaw mis ar y mwyaf.

Effaith y Gorchymyn fydd cau'r Stryd Fawr, Pontypridd dros dro, o'i chyffordd â Broadway (A4058), yn gyffredinol tua'r de-orllewin, i'w chyffordd â Stryd yr Undeb.

Mae angen y cyfyngiad fel bydd modd cynnal y gwaith ar y ffordd neu yn ei hymyl, sef:

**I. Twll Prawf, gwaith ymchwilio a gwaith paratoi.**  
Rydyn ni'n disgwyl bydd yr heol wedi'i chau o 0600 ar ddydd Sul 9 Mehefin hyd at 0600 ar ddydd Llun 10 Mehefin 2019.

**II. Cwblhau'r cysylltiadau terfynol**  
O 1800 dydd Sadwrn 15 Mehefin tan 0600 dydd Llun 17 Mehefin 2019.

Ac ar benwythnosau wedi hynny os oes angen hyd nes bod y gwaith wedi'i gwblhau.



**(TEMPORARY ROAD CLOSURE) ORDER 2019**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close High Street, Pontypridd, from its junction with Broadway (A4058), generally south westerly, to its junction with Union Street.

The restriction is necessary to enable works to be executed on or near the road namely:

**I. Trial Hole/Investigation works and undertaking enabling works**

It is expected to be in operation from 0600 hours on Sunday 9th June to 0600 hours on Monday 10th June 2019

**II. Completion of final connections**

From 1800 hours on Saturday 15th June to 0600 hours on Monday 17th June 2019

And on subsequent weekends if required until the works are complete


**Alternative Route** – from the eastern side of the closure proceed via Broadway (A4058), Sardis Road (A4058), Sardis Road, Factory Lane, Llantrisant Road, and High Street to the western side of the closure.

From the western side of the closure proceed via High Street, Llantrisant Road, Factory Lane, Sardis Road, Pontypridd Inner Relief Road, Mill Street, Sardis Road (A4058), Broadway (A4058), Broadway Interchange (A470), Broadway (A4058) to the eastern side of the closure.

Access will **NOT** be maintained for emergency service vehicles

Access will be maintained for pedestrians
