Mae angen cau'r ffordd er mwyn rhoi craen ar y briffordd


Mae disgwyl i'r craen gael ei ddefnyddio rhwng 8.00am a 5.00pm ddydd Llun 20 Mai 2019

**(TEMPORARY ROAD CLOSURE) NOTICE 2019**

**NOTICE IS GIVEN** by Rhondda Cynon Taff County Borough Council ("the Council") that in accordance with its powers under Section 14(2) of the Road Traffic Regulation Act 1984 (as amended) the following length of road shall be closed for a maximum period of 5 days.

The effect shall be to close Volunteer Street, from its junction with Carne Street, south westwards for a distance of 10m

The closure is necessary to facilitate a crane to be located in the highway


It is expected to be in operation between the hours of 8:00am – 5:00pm on Monday 20th May 2019

During the period of the closure the alternative route is as follows:

From the southern side of the closure, proceed via Albert Street, Windsor Street and Carne Street to the northern side of the closure

Access will be maintained for emergency service vehicles and pedestrians
