GORCHYMYN (CAU FFORDD DROS DRO) 2019

DYMA HYSBYSIAD bod Cyngor Bwrdeistref Sirol Rhondda Cynon Taf yn bwriadu gwneud Gorchymyn, ar ôl o leiaf 7 diwrnod o ddyddiad yr Hysbysiad yma, o dan Adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984, fel y'i diwygiwyd gan Ddeddf Traffig Ffyrdd (Cyfyngiadau Dros Dro) 1991, a fydd yn para deunaw mis ar y mwyaf.

Effaith y Gorchymyn fydd cau Pont Cynon ar y B4275 am gyfnod dros dro, o bwynt sydd 40 metr tua'r gogledd-ddwyrain o'i chyffordd â Heol Abercynon, tua'r gogledd-ddwyrain am bellter 40 metr.

Mae angen y cyfyngiad fel bydd modd cynnal y gwaith ar y ffordd neu yn ei hymyl.

Mae disgwyl y bydd y bont ar gau am gyfnod o 3 wythnos rhwng 22 Gorffennaf ac 2 Medi 2019, neu hyd nes y bydd y gwaith wedi'i gwblhau.



(TEMPORARY ROAD CLOSURE) ORDER 2019

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close the B4275 Pont Cynon Bridge, from a point 40 metres north east of its junction with Abercynon Road, north eastwards for 40 metres

The restriction is necessary to enable works to be executed on or near the road

The closure is expected to be in force for a 3 week period between 22nd July and 2nd September 2019 or until such times as the works have been completed


Advanced signage will be placed on the site 7 days prior to closure to inform the public when the closure will be in operation

Alternative Route – from the north eastern side of the closure, proceed via B4275, A4059, Mountain Ash Bridge, Commercial Street, High Street, Llanwonno Road, Hawthorn Terrace, Glamorgan Street and Abercynon Road to the south western side of the closure.

For vehicles travelling in the opposite direction, reverse the directions given above.

Access will be maintained for pedestrians and emergency service vehicles
