Effaith y Gorchymyn fydd cau'r Sgwâr, Llanharan (yr A473) dros dro am bellter o tua 2.2 cilometr i gyfeiriad y de-ddwyrain yn gyffredinol, gan ddod i ben cyn cylchfan Heol-y-Twyn.

Mae angen y cyfyngiad fel bydd modd cynnal y gwaith ar y ffordd neu yn ei hymyl.


Mae disgwyl i'r cyfyngiad ddod i rym am 10pm ar 24 Mehefin tan 6am ar 25 Mehefin 2019.

(TEMPORARY ROAD CLOSURE) ORDER 2019

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close The Square, Llanharan (A473) for a distance of approximately 2.2 kilometres in a generally south-easterly direction terminating prior to the Heol-Y-Twyn roundabout.

The restriction is necessary to enable works to be executed on or near the road


The closure is expected to be in force from 2200 hours on 24th June to 0600 hours on 25th June 2019

Alternative Route – from the eastern side of the closure proceed via the A473, Cowbridge/Llantrisant Road (A4222), Llanhari Road and Bridgend Road

For vehicles travelling in the opposite direction, reverse the directions given above.

Access will be maintained for pedestrians and emergency service vehicles
