Mae angen y cyfyngiad fel er mwyn cynnal gwaith ar y ffordd neu wrth ei hymyl.



(TEMPORARY ROAD CLOSURE) ORDER 2019

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close the unnamed road from Trehafod Road to Woodfield Terrace, Trehafod

The restriction is necessary to enable works to be executed on or near the road


The closure is expected to be in operation from 26th July 2019 for a period of 18 months or until such times as the works have been completed

Alternative Route - From the northern side of the closure proceed via Coedcae Road, Heol-Y-Parc and Woodfield Terrace to the southern side of the closure

For vehicles travelling in the opposite direction, reverse the directions given above.

Access will be maintained for pedestrians and emergency service vehicles
