1. Bydd "Gorchymyn Cydgrynhau (Gwahardd a Chyfyngu ar Aros a Llwytho a Mannau Parcio ar ochr y Ffordd) Cyngor Bwrdeistref Sirol Rhondda Cynon Taf 2012" yn cael ei amrywio fel bod y Gorchymyn y cyfeiriwyd ato fel "Gorchymyn Cyfyngu ar Aros Cyngor Sir Morgannwg Ganol (Y Rhodfa, Cefnpennar, Aberpennar) 1979" yn cael ei ddirymu yn ei gyfanwydd.

ATODLEN 2 – Gwahardd Aros ar Unrhwy Adeg

1. Y Rhodfa, Cefnpennar

- a. Ar ochr ogledd-ddwyreiniol y ffordd gerbydau, o bwynt gyferbyn â ffin ogledd-ddwyreiniol Rhif 36 Y Rhodfa, Cefnpennar, i ffin ogledd-orllewinol Rhif 37 Y Rhodfa, Cefnpennar. Mae'n bellter o oddeutu 30 metr.
- b. Ar ochr ogledd-ddwyreiniol y ffordd gerbydau, o bwynt tua 5 metr i'r gogledd-orllewin o ffin de-orllewinol Rhif 47 Y Rhodfa, Cefnpennar, i bwynt 6 metr i'r de-ddwyraint o ffin de-ddwyreiniol Rhif 66 Y Rhodfa, Cefnpennar. Mae'n bellter o oddeutu 169 metr.

(VARIATION AND WAITING RESTRICTIONS) ORDER 2025

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Order specified in Schedule 1
2. Introduce Waiting Restrictions on the lengths of roads specified in Schedule 2

Objections to the proposal together with the grounds on which they are made must be sent in writing to the Traffic Manager, Floor 2, 2 Llys Cadwyn, Taff Street, Pontypridd, CF37 4TH or by email on trafficservices@rctcbc.gov.uk by 21st February 2025.

SCHEDULE 1 – Variation

1. The "Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2012" shall be varied in that the order referred to as "Mid Glamorgan County Council (The Avenue, Cefnpennar, Mountain Ash) (Prohibition of Waiting) Order, 1979" shall be revoked in its entirety.

SCHEDULE 2 – Prohibition of Waiting At Any Time

1. The Avenue, Cefnpennar

- a. On the north-eastern side of the carriageway, from a point opposite the north-eastern boundary of No. 36 The Avenue, Cefnpennar, to the north-western boundary of No. 37 The Avenue, Cefnpennar. A distance of approximately 30 meters.
- b. On the north-eastern side of the carriageway, from a point approximately 5 meters north-west from the south-western boundary of No. 47 The Avenue, Cefnpennar, to a point 6 meters south-east of the south-eastern boundary of No. 66 The Avenue, Cefnpennar. A distance of approximately 169 meters.
