DATGANIAD O'R RHESYMAU

Mae'r cyfyngiadau Gwahardd Aros Ar Unrhyw Adeg presennol ar hyd pob ochr i'r briffordd sy'n mynd trwy'r Rhodfa, Cefnpennar yn achosi problemau parhaus i drigolion gan nad oes modd iddyn nhw barcio eu cerbydau'n gyfreithlon ger eu cartrefi. Bydd y cynigion i ddirymu rhan o'r cyfyngiadau Gwahardd Aros Ar Unrhyw Adeg yn helpu i lliniaru'r mater yma.

Yn dilyn arolwg safle a chael cyfartaledd y llif bob dydd trwy'r ardal, daethpwyd i'r casgliad y byddai dirymu'r cyfyngiadau Gwahardd Aros Ar Unrhyw Adeg, tua 80 metr ar hyd cyrion dwyreiniol pellaf y briffordd, o fudd i drigolion heb amharu ar y llif traffig drwy'r ardal.

Caiff y mesurau hyn eu cynnig o dan Ddeddf Rheoleiddio Traffig 1984 i roi mwy o gyfleoedd parcio i drigolion Y Rhodfa, Cefnpennar a'r cyhoedd yn gyffredinol, wrth hefyd gynnal tramwy cerbydau a diogelwch defnyddwyr y briffordd.

(VARIATION AND WAITING RESTRICTIONS) ORDER 2025

STATEMENT OF REASONS

The existing Prohibition of Waiting at Any Time (POWAAT) restrictions along each side of the highway passing through The Avenue, Cefnpennar is causing ongoing issues for residents as they are unable to park their vehicles near their homes legitimately. The proposals to revoke a section of the POWAAT restrictions will help to mitigate this issue.

Following a site survey and the acquiring of the Average Daily Traffic (ADT) through the area, it has been deduced that revocation of the POWAAT restrictions, about a circa 80m span of the highway's eastern extremity, will prove beneficial to residents whilst not impeding the flow of traffic through the area.

These measures are proposed under the Road Traffic Regulation Act 1984 to afford more parking opportunity to residents of The Avenue, Cefnpennar and the wider public, whilst maintaining passage of traffic and the safety of highway users.
