

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2, 4 and 124 Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Order specified in Schedule 1
2. Introduce Waiting Restrictions as specified in Schedule 2

**SCHEDULE 1 – Variation**

The "Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On-Street Parking Places) Consolidation Order 2012" is hereby varied as specified below:

- a. The "Rhondda Cynon Taff County Borough Council (Station Road, Maerdy Road and Ceridwen Street, Maerdy) (Revocation, Variation, Prohibition of Waiting at Any Time, Loading Only and Prohibition of Loading and Unloading) Order 2009" shall be varied by the deletion of items (a) and (b) from Part 3 of the Schedule

**SCHEDULE 2 – Prohibition of Waiting At Any Time**


**1. Oxford Street**

- a. The north-eastern side, from its junction with Station Road, south-eastward to the common boundary between Nos. 46 and 47 Oxford Street
- b. The south-western side, from its junction with Station Road, south-eastward to the common boundary between Nos. 42 and 43 Oxford Street

**2. Station Road**

- a. The north-western side, from its junction with Maerdy Road to the common boundary between Nos. 13 and 14 Station Road
- b. The south-eastern side, from its junction with Maerdy Road to a point opposite the common boundary between Nos. 11 and 12 Station Road
