**PRE-STATUTORY CONSULTATION**

**PENRHIWCEIBR PRIMARY SCHOOL**

**PROPOSED PROHIBITION OF WAITING, LOADING AND UNLOADING AT ANY TIME**

The Council has developed proposals to introduce prohibition of waiting, loading and unloading at any time to the entrance of Penrhiwceibr Primary School from Cross Street (please refer to the enclosed plan for the full location and extents of the proposal).

The proposal would help to keep the entrance to Penrhiwceibr Primary School, including the dropped kerbs, free of obstructions and provide better accessibility and visibility for those accessing the school.

As a result of this proposal The Council are holding a pre-statutory consultation.
