STATUTORY CONSULTATION
LLEWELLYN STREET, PONTYGWAITH – PROPOSED AMENDMENTS TO
WAITING RESTRICTIONS

Following close of the pre-statutory consultation, for which we would like to thank those who made comment, the Council is proposing to remove the length of the prohibition of waiting restrictions (operating 8.00am to 6.00pm, Monday to Saturday inclusive of) outside Nos. 24 to 26 Lewellyn Street.

The reduction in the extents of the prohibition of waiting restrictions would provide additional parking, making it easier for both residents to park near to their homes and for those visiting the area to access the shops and amenities.

The remaining of the prohibition of waiting restrictions outside of Nos. 27 to 33 Llewellyn Street will be retained to ensure that there is sufficient room for buses to pull over, allowing vehicles to pass, during the prohibition's operational hours.

As a result of the proposal the Council are holding a statutory consultation.
