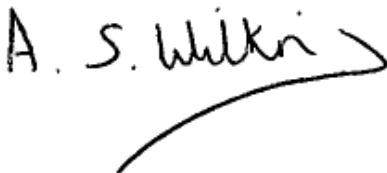

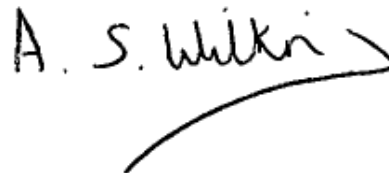

**SCHEDULE 1 – Prohibition of Waiting At Any Time**

**Glenavon Terrace, Gilfach Goch**

1. The south-western and north-western side, from a point 48.3 metres north-west of its junction with High Street, north-westwards then north-eastwards for a total distance of 20.5 metres
2. The north-eastern and southeast side, from a point 31.7 metres north-west of its junction with High Street, north-westwards then north-eastwards for a total distance of 20 metres
