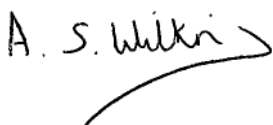
1. Teras Gwendoline, Abercynon

- b. Yr ochr de-ddwyreiniol, o bwynt sydd 6 metr i'r de-orllewin o bwynt sydd mewn llinell â ffin eiddo gyffredin Rhifau 9 a 10 Teras Gwendoline, tua'r de-orllewin hyd at ddiwedd y ffordd

2. Llys yr Ymerodraeth, Abercynon

- a. Y ddwy ochr, o bwynt sydd 3.2 metr i'r de-ddwyrain o bwynt sydd mewn llinell â ffin gogledd-orllewinol eiddo Rhif 12 Llys yr Ymerodraeth, tua'r gogledd-orllewin hyd at ddiwedd y ffordd

(WAITING RESTRICTIONS) ORDER 2026

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2, 4 and 124 Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, the effect of which will be to:

1. Introduce Waiting Restrictions as specified in Schedule 1

SCHEDULE 1 – Prohibition of Waiting At Any Time

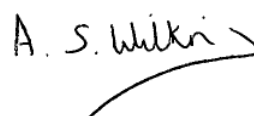
1. Gwendoline Terrace, Abercynon

- a. The north-western side, from a point 4.7 metres south-west of a point in line with the common property boundary of Nos. 8 and 9a Gwendoline Terrace, south-westwards for its entire remaining length
- b. The south-eastern side, from a point 6 metres south-west of a point in line with the common property boundary of Nos. 9 and 10 Gwendoline Terrace, south-westwards for its entire remaining length

2. Imperial Court, Abercynon

- a. Both sides, from a point 3.2 metres south-east of a point in line with the north-western property boundary of Nos. 12 Imperial Court, north-westwards for its entire remaining length
