1. Teras Brynhill, Pentre'r Eglwys Uchaf

- a. Yr ochr dde-ddwyreiniol, o bwynt sydd mewn llinell â phalmant de-orllewinol Heol Sant Illtyd, tua'r de-orllewin am bellter o 7.9 metr

2. Cae Ffynnon, Pentre'r Eglwys Uchaf

- a. Y ddwy ochr, o'i chyffordd â Phen-Yr-Eglwys, tua'r gogledd-orllewin am bellter o 6 metr

3. Heol yr Eglwys, Pentre'r Eglwys Uchaf

- a. Yr ochr de-ddwyreiniol, o bwynt sydd mewn llinell ag ymyl palmant gogledd-ddwyreiniol Heol Sant Illtyd, tua'r gogledd-ddwyrain am bellter o 10 metr

4. Maes-Yr-Eglwys, Pentre'r Eglwys Uchaf

- a. O'r ochr ogledd-orllewinol, o'i chyffordd â Heol Sant Illtyd, tua'r gogledd-ddwyrain am 10 metr.

5. Pen-yr-eglwys, Pentre'r Eglwys Uchaf

- a. Yr ochr ogledd-orllewinol, o'i chyffordd â Heol Sant Illtyd, tua'r de-orllewin am bellter o 61.3 metr
- b. Yr ochr dde-ddwyreiniol o'i chyffordd â Heol Sant Illtyd, tua'r de-orllewin am bellter o 51.2 metr

6. Heol Sant Illtyd, Pentre'r Eglwys Uchaf

- a. Yr ochr ogledd-ddwyreiniol o'i chyffordd â Heol yr Eglwys, tua'r de-ddwyrain am bellter o 6.5 metr
- b. Yr ochr ogledd-ddwyreiniol, o bwynt sydd 13.3 metr i'r gogledd-orllewin o bwynt sydd mewn llinell â ffin eiddo gyffredin Rhifau 1 a 2 Bwthynnod Llwyn-Onn, tua'r de-ddwyrain am bellter o 97 metr
- c. Yr ochr dde-orllewin, o'i chyffordd â Theras Brynhill tua'r de-ddwyrain am bellter o 168.5 metr

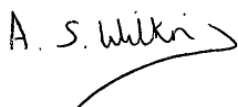
7. Heol Sant Illtyd (Mynediad Bythynnod Llwyn-onn), Pentre'r Eglwys Uchaf

- a. O'r ochr ogledd-orllewinol, o'i chyffordd â Heol Sant Illtyd, tua'r gogledd-ddwyrain am bellter o 18.4 metr
- b. Yr ochr ddwyreiniol, o'i chyffordd â Heol Sant Illtyd, tua'r gogledd-ddwyrain am bellter o 30.3 metr

8. Tŷ Draw, Pentre'r Eglwys Uchaf

- a. Y ddwy ochr, o'i chyffordd â Phen-yr-eglwys, tua'r de-ddwyrain am bellter o 10 metr

(WAITING RESTRICTIONS) ORDER 2026

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2, 4 and 124 Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, the effect of which will be to:

1. Introduce Waiting Restrictions as specified in Schedule 1 and 2

SCHEDULE 1 – Prohibition of Waiting At Any Time

1. Brynhill Terrace, Upper Church Village

- a. The south-east side, from a point in line with the south-western kerb-line of St Illtyds Road, south-westwards for a distance of 7.9 metres

2. Cae Ffynnon, Upper Church Village

- a. Both sides, from its junction with Pen-Yr-Eglwys, north-westwards for a distance of 6 metres

3. Church Road, Upper Church Village

- a. The south-east side, from a point in line with the north-eastern kerb-line of St Illtyds Road, north-eastwards for a distance of 10 metres

4. Maes-Yr-Eglwys, Upper Church Village

- a. Both sides, from its junction with St Illtyds Road, north-eastwards for a distance of 10 metres

5. Pen-Yr-Eglwys, Upper Church Village

- a. The north-west side, from its junction with St Illtyds Road, south-westwards for a distance of 61.3 metres
- b. The south-east side, from its junction with St Illtyds Road, south-westwards for a distance of 51.2 metres

6. St Illtyds Road, Upper Church Village

- a. The north-east side, from its junction with Church Road, south-eastwards for a distance of 6.5 metres
- b. The north-east side, from a point 13.3 metres north-west of a point in line with the common property boundary of Nos. 1 and 2 Llwyn-Onn Cottages, south-eastwards for a distance of 97 metres
- c. The south-west side, from its junction with Brynhill Terrace, south-eastwards for a distance of 168.5 metres

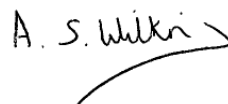
7. St Illtyds Road (Access to Llwyn-Onn Cottages)

- a. The west side, from its junction with St Illtyds Road, north-eastwards for a distance of 18.4 metres
- b. The east side, from its junction with St Illtyds Road, north-eastwards for a distance of 30.3 metres

8. Ty Draw, Upper Church Village

- a. Both sides, from its junction with Pen-Yr-Eglwys, south-eastwards for a distance of 10 metres
