Bydd y ffordd ar gau rhwng **20 a 30 Ionawr 2026**, neu hyd nes i'r gwaith gael ei orffen.

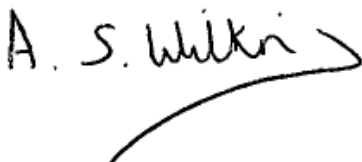

(TEMPORARY ROAD CLOSURE) NOTICE 2026

NOTICE IS GIVEN by Rhondda Cynon Taff County Borough Council ("the Council") that in accordance with its powers under Section 14(2) of the Road Traffic Regulation Act 1984 (as amended) the following length of road shall be closed for a maximum period of 21 days.

The closure is necessary to facilitate emergency repairs to a burst water main.

The closure will be in operation **between 20th January – 30th January 2026**, or until such time as the work has been completed.

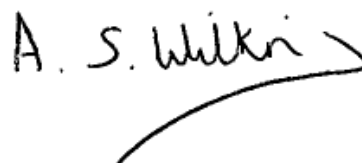
Temporary Road Closure

Oxford Street, from the eastern side of its junction with Rhyd-y-Helyg, south-eastwards for a distance of 190 metres.

Alternative Route – Available via Oxford Street Roundabout, Heol Crochendy and A4054 Main Avenue

Access will be maintained for emergency services, pedestrians and to premises.
