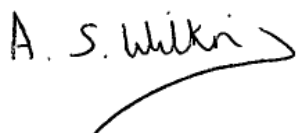

**(TEMPORARY CLOSURE) NOTICE 2026**

**NOTICE IS GIVEN** by Rhondda Cynon Taff County Borough Council ("the Council") that in accordance with its powers under Section 14(2) of the Road Traffic Regulation Act 1984 (as amended) the following length of road shall be restricted for a maximum period of 21 days.

The closure is necessary in the interests of public safety during a principal inspection of the Cowbridge Road Footbridge.

The restrictions will be in operation **between 8:00am – 3:00pm on Saturday 15th August 2026**, or until such times as the works have been completed.

**Temporary Road Closure**

Active Travel Route Number RCT-INM-S42 (from Cowbridge Road to Cardiff Road, Llantrisant) – from its junction with Cowbridge Road, south-westwards for a distance of 20 metres and then north-eastwards for a distance of 35 metres

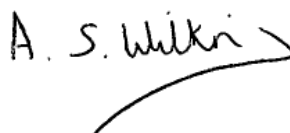
**Alternative Route:**

Available via Active Travel Route Number RCT-INM-S42, Fanheulog and Cowbridge Road.

Access will be maintained to premises.

Access **WILL NOT** be maintained for pedestrians or emergency services.
